TO PARTICIPATE. The potential Grand Prize Winner will be notified by telephone or email starting on October 18, 2024 at/after 12:00 PM (noon) EST. Entrants must provide a valid telephone number and email address in order to be notified if selected as a potential winner. The Grand Prize Winner must be willing and able to travel on the dates selected by the Sponsor so as to attend Sponsor's choice of a 2024 MLB World Series game which will take place in late October 2024/early November 2024.

Grand Prize Winner and his/her guests agree to comply with all applicable ballpark and venue regulations in connection with the Grand Prize. Sponsor and the MLB Entities reserve the right to remove or to deny entry to the Grand Prize Winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the game/event/exhibition. Major League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

All Grand Prize details are at Sponsor's sole discretion.
